- Active LS Membership** \$170 Any Registered Land Surveyor in good standing in the State of Montana.
- Associate Membership** \$50 Any person actively training as a land surveyor under the direct supervision of a licensed professional land surveyor or who is enrolled as a student in a higher education surveying curriculum, and is recommended by an Active, Fellow, or Life Member of MARLS.
- Affiliate Membership** \$130 Any person in a profession or business associated with the profession of land surveying who is approved by the MARLS Board of Directors.
- Sustaining Membership** \$170 An individual or institution that desires to assist financially in the work of the Association.
- Sustaining - Health Insurance Membership** \$170 An individual or institution that desires to assist financially in the work of the Association.
- Non-Resident LS Membership** \$130 Any person registered as a Land Surveyor who resides outside Montana and does not practice in Montana.
- Emeritus Membership** \$65 Any person who has been registered in the State of Montana as a Land Surveyor, and who otherwise complies with the requirements for Emeritus Status as specified by the State of Montana, Board of Registration for Professional Engineers & Land Surveyors.
- Student Membership** \$20 Any person who is enrolled as a student in a higher education surveying curriculum.

#### **RECRUITMENT INCENTIVE PROGRAM**

Any active member who recruits a new associate member will receive a credit of \$5 on his or her dues assessment.

Any associate member who recruits a new associate member will receive a credit to his or her dues equal to one-third of the dues assessment.

To claim the dues credit, the recruiting member must sign the membership application form along with the new member and note on the application form that it is a recruitment incentive application.

TAX INFORMATION: Federal tax law limits the deductibility of membership dues expended for legislative purpose. The 2011-2012 year MARLS reasonably estimates the deductible portion of your dues to be 84%.
